(a) of the Office of the Special Prosecutor Act, 2017 is to investigate and prosecute cases of alleged corruption and corruption related offences under the Public Procurement Act, 2003 (Act 663). In view of this, The Editorial Team has dedicated this edition of the E-Bulletin to reflect on some of the provisions regarding offences and corruption in Public Procurement and identify some its associated challenges to progress.

The Cambridge Dictionary defines Offense as 'an illegal act; a crime' or 'a punishable act'. Offenses relating to Public Procurement in Ghana are defined in the Public Procurement Act, 2003 (Act 663) as amended. According to Section 92(2) of Act 663 as amended, an Offense constitutes

- a. Entering or attempting to enter into a collusive agreement, whether enforceable or not, with any other supplier or contractor where the prices quoted in their respective tenders, proposals or quotations are or would be higher than would have been the case has there not been collusion between the persons concerned;
- Directly or indirectly influencing in any manner or attempting to influence in any manner the procurement process obtains an unfair advantage in the award of a procurement contract;
- c. Altering a procurement document with intent to influence the outcome of a tender proceeding and

this includes but is not /limited to

- i. forged arithmetical correction;
- ii.. insertion of documents such as Bid Security or Tax Clearance Certificate which were not submitted at Bid Opening; and
- d. Request for clarification in a manner not permitted under this Act.

Corruption is defined by the Transparency International as 'the abuse of entrusted power for private gain. It can be classified as grand, petty and political, depending on the amounts of money lost and the sector where it occurs'. It is believed that Corruption has been part of human institutions 'since Adam', thus it is difficult to eradicate it. However, as outlined in Criminal Code, 1960 (ACT 29) as amended, Corruption has many facets but the one of the most pervasive of them all is that which occurs in the public procurement processes.

ccording to the OECD, Public procurement is one of the government activities most vulnerable to corruption due to the sheer volumes of transactions and the financial interests at stake. Its risks are exacerbated by the complexity of the process, the close interaction between public officials and businesses, and the multitude of stakeholders involved. Risk of corruption can be encountered in almost all the phases in the Procurement Cycle, be it, Procurement Planning Phase, Procurement Invitation/Process Phase and/or Contract Award and Performance Phase. Thus, lack of transparency, limited access to information and lack of accountability and control at each stage of the procurement process as outlined above culminates corruption.

Due to the hidden nature of corruption, it is difficult to measure its exact cost, however, it has been estimated that between 10%-30% of the investment in publicly funded construction projects in Africa may be lost through, mismanagement and corruption (CoST, 2012). The Institute of Economic Affairs (IEA), in November/December 2015 undertook a corruption survey to unearth the nature, levels, causes and motives behind corruption in Ghana. The survey revealed that corruption levels are considered very high by 72.1% of the respondents.



Corruption in Public Procurement results in increase in government operational cost, it complicates Government budgets and the economy and undermine development. Corruption is a serious socio-economic problem and must be fought with every reform to eradicate it.

Corruption impacts societies in a multitude of ways. In the worst cases, it costs lives. Short of this, it costs people their freedom, health or money. The cost of corruption can be divided into four main categories: political, economic, social and environmental. On the political front, corruption is a major obstacle to democracy and the rule of law. In a democratic system, offices and institutions lose their legitimacy when they're misused for private advantage. It is extremely challenging to develop accountable political leadership in a corrupt climate.

Economically, corruption depletes national wealth. Corrupt politicians invest scarce public resources in projects that will line their pockets rather than benefit communities, and prioritise high-profile projects such

as dams, power plants, pipelines and refineries over less spectacular but more urgent infrastructure projects such as schools, hospitals and roads.

Corruption corrodes the social fabric of society. It undermines people's trust in the political system, in its institutions and its leadership. Environmental degradation is another consequence of corrupt systems. The lack of, or non-enforcement of, environmental regulations and legislation means that precious natural resources are carelessly exploited, and entire ecological systems are ravaged. From mining, to logging, to carbon offsets, companies across the globe continue to pay bribes in return for unrestricted destruction.

Considering the ills that corruption can breed in any nation, it must not be treated with kids' gloves at all, rather it calls for a concerted effort by individuals and from all stakeholders to join forces to fight corruption to the latter.

Trial of 4 Former NCA Bosses Begins

he trial of a former Director-General and three former board members of the National Communications Authority (NCA) and a businessman accused of causing \$4 million financial loss to the state commenced on January 16, 2018.

The accused persons are the former Director-General, William Matthew Tetteh Tevie, and the former board members — Eugene Baffoe-Bonnie, Nana Owusu Ensaw and Alhaji Salifu Mimina Osman — and the businessman, George Derek Oppong. They have been accused among other things including engaging in infractions in the procurement of listening devices for the state.

During the trial, the Director of Legal Services at the National Communications Authority (NCA), Abena Asafo Adjei, serving as the first prosecuting witness denied knowledge of \$4m deal in court. She told the court that, she had no knowledge of a contract signed between the Authority and Infralocks Development Limited.

The trial continues and the Ghanaian people are anxious to know what the final outcome would be.

President Takes A Strong Stand Against Corruption in Ghana

Fighting corruption has been one of the major focus of His Excellency Nana Addo Dankwa Akufo-Addo although the President has been in government for just one year.

The President's resolve to fighting corruption in the country remains unshaken with the recent signing of the Special Prosecutor Bill and the appointment of "citizen vigilante" Martin Amidu as Ghana's first Special Prosecutor.

During the inauguration of the Fifth President of the Fourth Republic, President Akufo-Addo promised to make the fight against corruption his topmost priority.

According to the President, there was a need to restore integrity in the Public Sector. "State coffers are not spoils for the party that wins an election but resources for the country's essential and economic development. I shall protect the public purse and insist on value for money" he stated during his inauguration speech.

The President also in a speech addressing a section of Ghanaian community in the United Kingdom (UK) at a public forum said the persistent engagement of some state officials and private individuals in acts of corruption is undermining the capacity of the country to control its own development hence the need for stiffer legislations to tackle corruption.

On Wednesday January 17, 2018 in the President's second Media Encounter a year after being sworn into office, he said the Special Prosecutor will prosecute corrupt office holders as well as past corrupt officials.

To show his commitment to fighting corruption, the president said every single allegation of corruption in his one-year-old administration will be thoroughly investigated. "Every single act of alleged of corruption labeled against any member of my administration has been or is in the process of being investigated by Independent Bodies" the president stated.

His Excellency, Nana Addo Dankwa Akufo-Addo is very confident that the naming of "citizen vigilante" Martin Amidu as Ghana's first Special Prosecutor will tackle the canker head-on.

SAFEGUARDING THE PUBLIC PURSE THROUGH ENHANCED PROCUREMENT

hana has made savings to the tune of GHL782 million over the past one year through the introduction of stringent measures by the Public Procurement Authority (PPA) to address waste in the procurement and supply management sector. This was announced by the president at the 2nd media encounter held on Thursday 18th January, 2018, at the Flagstaff House.

In a related development, Mr. AB Adjei, the Chief Executive of the Public Procurement Authority, said the amount, otherwise would have been eroded through padded contracts sum and other procurement malpractices.

Mr. Adjei made this known at the launch of the Ghana Institute of Procurement and Supply's (GIPS) Code of Ethics for procurement and supply professionals recently in Accra, commended the institution for the effort aimed at addressing some of the ethical challenges of the profession.

He said the prevailing narrative of non-compliance and corruption in the practice continued to dent the image of the procurement profession. To him, it is even more disheartening to realize that, procurement professionals who are supposed to guide our political leaders to save the public purse, end up conniving with them and sometimes misconducting themselves under the guise of fear of threats of demotion, loss of jobs or relegation to the background in their institutions.

Mr. Adjei said this must no longer be entertained, and that persons found culpable of misconducting themselves in their line of duty would be made to face sanctions as spelt out in the GIPS Code of Ethics and Conduct in addition to any other legal and disciplinary actions as permitted under the law.

He urged procurement professionals to be bold and assertive in pointing out wrongful acts and respectfully submit their professional stance to their bosses when the need arises.

"This therefore calls for a united front which GIPS is prepared to provide for all procurement professionals and practitioners through its Code of Ethics and Conduct".

He said procurement in recent times become a key economic and political activity of governments all over the world, and no more a simple act of purchasing, but rather, a development tool that had the ability to transform public finance into developmental outcomes. It has become an essential element in governance that our political leaders must deploy with tact and skill in order to execute their practices and accomplish the desired benefits for their citizens.

He said to this end, the new PPA, under his leadership has established two purpose-driven operational units made up of the Due Diligence and Value for Money, and the Procurement Audit Units respectively, to enhance the credibility of the Authority's operations and processes.

The Due Diligence and Value for Money Unit, he said has been created with clear terms of reference to determine the reasonableness or otherwise of jurisdictions provided by Entities in their applications for Sole Source and Restricted Tendering as they related to the appropriate provisions of the Procurement Act 663 as amended.

According to the Chief Secretary to the President and Cabinet Dr. Misheck Sibanda, the appointment with immediate effect was done in terms of section 8 of the Public Procurement and Disposal of Public Assets Act which abolishes the State Procurement Board (SPB).

The board will be chaired by Mrs Vimbai Nyemba who will be deputized by Ambassador Buzwani Donald

Mothobi. Other new board members are Retired Colonel Joseph Mhakayakora, Engineer Cletus Nyachowe, Ms Ntombehle Moyo, Mrs Roseline Nhamo, Ms Ottilia Murasi and Retired Major Dr Thomas Utete Wushe.

In line with section 8 (2) of the Act, the members were selected in recognition of the requirement to have board members with the requisite skills in specified areas as well as to ensure that women are involved.

The awarding of tenders will now be done by accounting officers in various State departments and companies, with the Procurement Regulatory Authority only playing a supervisory and monitoring role to ensure Government entities comply with the new Public Procurement and Disposal of Public Assets Act and other set standards.

DID YOU KNOW

Did you know that there are remedies available to disgruntled tenderers?

If for some reason a tenderer (Supplier, Contractor or Consultant) is dissatisfied with the conduct, results or communication of a tender or procurement process, he/she could seek an administrative review from the Public Procurement Authority.

However, Tenderers should note that the following are not subject to review.

The selection of a method of procurement;

The choice of selection procedure;

The limitation of procurement proceedings

A decision by the entity to reject tenders, proposals, offers or quotations

A complainant can seek administrative review directly at the Public Procurement Authority within twenty-one (21) days of any of the following instances:

The complaints submitted at the Entity level is not resolved with twenty-one (21)days;

Dissatisfaction with and/or adversely affected by the written decision of the Head of Entity
